विषय:- ग्राम पंचायतों की वार्षिक कार्ययोजना में फ्लैगशिप योजना से सम्बन्धित गतिविधियों को सम्मिलित किये जाने के संबंध में।

महोदय,

कृपया पंचायती राज, मंत्रालय, भारत सरकार द्वारा प्रेषित पत्रांक-डी.ओ.नं० एम-11015/368 /2022-सी.बी.-पार्ट (4)(29163) दिनांक 14 मार्च, 2023 एवं 27 मार्च, 2023 (छायाप्रति संलग्न) का सन्दर्भ ग्रहण करने का कष्ट करें, जिसके अन्तर्गत प्रमुख फ्लैगशिप योजनाएं एवं उनसे सम्बन्धित गतिविधियों को जी.पी.डी.पी. में सम्मिलित किए जाने सम्बन्धी एस.ओ.पी. (छायाप्रति संलग्न) राज्यों को उपलब्ध कराने तथा इस सम्बन्ध में समस्त राज्यों का उन्मुखीकरण किये जाने के विषय में अवगत कराते हुए आवश्यक कार्यवाही किये जाने के निर्देश दिये गये हैं। इस सम्बन्ध में पंचायती राज निदेशालय द्वारा भी पत्रांक 5/आर. जी.एस.ए./391/2022/13/2021. दिनांक 29 सितम्बर, 2022 द्वारा निर्देश निर्गत है, जिससे कि एल.एस.डी.जी. पर आधारित थीमैटिक जी.पी.डी.पी. द्वारा वर्ष 2030 तक सतत् विकास लक्ष्यों की शत-प्रतिशत संतृप्तता पर कार्य किया जा सके।

पंचायती राज, मंत्रालय, भारत सरकार द्वारा अपने उक्त पत्र में ग्राम पंचायत कार्ययोजना तैयार करने के लिए ई-ग्राम स्वराज पोर्टल के प्लानिंग माड्यूल में परिवर्तन करते हुए एल.एस.डी.जी. की 09 थीम/विषय के साथ प्रमुख फ्लैगशिप योजनाओं को जोड़े जाने के विषय में अवगत कराते हुए वर्ष 2023-24 की जी.पी.डी.पी./वार्षिक कार्ययोजना 30 अप्रैल, 2023 तक ई-ग्राम स्वराज पोर्टल पर अपलोड किए जाने की अपेक्षा की है। वार्षिक कार्ययोजना तैयार किए जाने हेतु जनपदों द्वारा ध्यान में रखे जाने वाले महत्वपूर्ण बिन्दु संलग्न (संलग्नक-1) है। उल्लेखनीय है कि जी.पी.डी.पी. पोर्टल, मीटिंग ऑनलाइन, ई-ग्राम स्वराज पोर्टल इंटीग्रेटेड है, यदि ग्राम पंचायत स्तर पर उक्त उल्लिखित बिन्दुओं में से कोई कार्य अपूर्ण रहता है तो पंचायतों की वार्षिक कार्ययोजना अपलोड करने में समस्या आएगी।


उक्तानुसार भारत सरकार द्वारा दिए गए निर्देशों के परिपालन से पूर्व आवश्यक है कि जनपद स्तर से निम्नांकित कार्यवाही सुनिश्चित की जाए-

1. वार्षिक कार्ययोजना/जी.पी.डी.पी. को संलग्नक-1 में दिए गए निर्देशों के अनुरूप तैयार करने से पूर्व शासनादेश सं०: 2618/33-3-2015-10जी.आई./2015, दिनांक 29 सितम्बर, 2015 से गठित जिला क्रियान्वयन एवं समन्वयन समिति के अध्यक्ष जिलाधिकारी की अध्यक्षता में बैठक कराते हुए 09 थीम/विषय से सम्बन्धित विभागों के साथ फ्लैगशिप योजनाओं अन्तर्गत ग्राम पंचायतों में कराये जाने वाले कार्यों को वर्ष 2023-24 की कार्ययोजना में सम्मिलित कराये जाने पर चर्चा की जाए। प्रस्तावित एजेण्डा बिन्दु (संलग्नक-2)।
2. वित्त आयोग, स्वच्छ भारत मिशन(ग्रा०) के साथ विभिन्न विभागों की फ्लैगशिप योजनाओं से प्राप्त होने वाली धनराशि का विवरण ग्राम पंचायत को उपलब्ध कराया जाए तथा सम्बन्धित विभागों के ग्राम स्तरीय कार्यकर्ताओं की उपस्थिति में उक्त धनराशि से कराए जाने वाले कार्यों को सम्मिलित कराए जाने हेतु विभागों को निर्देशित किया जाए।



3. ग्राम सभा में मिशन अन्त्योदय के सर्वेक्षण में आए क्रिटीकल गैप पर भी चर्चा की जाए, यदि 2022-23 के सर्वेक्षण के आकड़े इस वर्ष उपलब्ध नहीं हैं तो वर्ष 2019-20 के आकड़े उपयोग में लाए जा सकते हैं।
4. उक्त रूप से ई-ग्राम स्वराज पोर्टल पर किए गए परिवर्तन पर उन्मुखीकरण हेतु दिनांक 01 अप्रैल से 15 अप्रैल, 2023 के मध्य समस्त ग्राम प्रधान, सचिव, पंचायत सहायक तथा लाइन डिपार्टमेंट का विकासखण्ड वार प्रशिक्षण अयोजित किया जाए तथा ग्राम पंचायतवार विभिन्न विभागों की फ्लैगशिप योजनाओं तथा उनसे सम्बन्धित गतिविधियों को सूचीबद्ध कर ग्राम पंचायतों से साझा किया जाए।
5. उक्त प्रशिक्षण के आयोजन का दायित्व सहायक विकास अधिकारी(पं०), डी.पी.आर.सी. फ़ैकल्टी, मंडलीय परियोजना प्रबंधक तथा जिला परियोजना प्रबन्धक द्वारा किया जाए।
अतः उपरोक्त के सम्बन्ध में मुझे यह कहने का निदेश हुआ है कि **जिला क्रियान्वयन एवं समन्वयन समिति** की बैठक एवं प्रशिक्षण की कार्यवाही पूर्ण करते हुए उक्तानुसार दिए गए निर्देशों के अनुरूप ग्राम पंचायतों की वार्षिक कार्ययोजना 30 अप्रैल, 2023 तक ई-ग्राम स्वराज पोर्टल पर अपलोड कराए जाने हेतु कार्यवाही कराना सुनिश्चित करें।



ई-ग्राम स्वराज पोर्टल पर एल.एस.डी.जी. की 09 थीम/विषय के साथ प्रमुख फ्लैगशिप योजनाओं को सम्मिलित किए जाने हेतु ध्यान में रखने वाले महत्वपूर्ण बिन्दु।

1. वाइब्रेन्ट ग्राम सभा पोर्टल (meetingonline.gov.in) पर ग्राम पंचायत द्वारा एल.एस.डी.जी. के 09 विषयों में से न्यूनतम 01 विषय (अधिकतम-02 विषयों) को अनिवार्यतः संकल्प के रूप में अंकित किया जाए एवं अनटाइड फंड से थीम संख्या 04- पर्याप्त जल युक्त गाँव एवं थीम संख्या 05- स्वच्छ और हरा-भरा गाँव के अतिरिक्त थीम/विषयों का चयन संकल्प के रूप में ग्राम पंचायतों द्वारा किया जाए।
2. संकल्प के रूप में चयनित थीम में प्रदर्शित कुल गतिविधियों में से 50 प्रतिशत गतिविधियों कार्ययोजना में सम्मिलित किया जाना अनिवार्य है।

Dear Madam / Sir,

As you are aware that Ministry has adopted thematic approach for the Localisation of Sustainable Development Goals (LSDGs) at grassroot level through PRIs. Accordingly, thematic Gram Panchayat Development Plan (GPDP) has to be prepared on revamped portal. The basic purpose of thematic GPDP is to achieve saturation on all SDGs by 2030.

2. To facilitate the preparation thematic GPDP, master GPDP was prepared in the Ministry with the inclusion of activities of all major flagship schemes and circulated to States. SoP was also circulated vide email dated 15.12.2023 for the same. During State/UT level orientation it was emphasised to include activities of all flagship schemes under thematic GPDP, irrespective of Sankalp taken in that theme or not. Hence, to provide ample clarity, it is once again reiterated that:

- (i) All the activities to be implemented / undertaken in a Gram Panchayat under flagship schemes of Central Government must be recorded in their Thematic GPDP.
- (ii) Like-wise activities of State Flagship scheme to be also included in Thematic GPDP.
- (iii) It may be possible that information in respect of all flagship schemes may not be available at GP level. Hence, Block Development Officers (BDOs) may provide requisite information through concerned officials of line department.
- (iv) If information in respect of forthcoming financial year is not available for inclusion in GPDP 2023-24, data of current year (2022-23) may be used.
- (v) A template regarding requisite data of major flagship schemes of Central Government, which will be required for inclusion in thematic GPDP is attached for ready reference (Annexure-I).

3. In view of the above, I request your personal intervention and necessary direction to the concerned officials to provide requisite data of major flagship schemes to Gram Panchayats for preparation of thematic GPDP adopting saturation approach.

Dear Madam / Sir,

As you are aware that eGramSwaraj portal has been revamped to prepare thematic GPDP, wherein it is necessary to include all the activities being implemented/undertaken in a Gram Panchayat (GP) under flagship schemes of Central and State Government, Own Source of Revenue, CSR funds etc.

2. During the VC meeting held with the States/UTs on 23rd March, 2023 to review the progress of preparation of GPDP, feedback is received that GPs are not getting information of flagship schemes needed to prepare thematic GPDP 2023-24 adopting saturation approach.

3. Therefore, to facilitate access of the GPs to the requisite information the best way is to organise 1-2 days' workshop at Block level with active participation of officers of District/Block level along with Elected Representatives and Functionaries of GPs. The concerned officers of line department to attend the Workshop and provide all requisite information of various activities being implemented in GPs under flagship schemes of Central and State Governments, as mentioned in the thematic master GPDP circulated earlier (copies attached).

4. The Block level workshop may be organised during 30th March to 10th April, 2023 to provide necessary data to GPs and subsequently GPs could prepare their GPDP and upload the same on the portal by 30th April, 2023. An indicative format for providing data by the line departments to GPs is at Annexure.

5. I, therefore, would request your personal intervention to issue necessary direction to the concerned officials to organise Block level workshop and to provide requisite data of all flagship schemes of Central and State Governments to GP for preparation of thematic GPDP 2023-24. Information of flagship scheme to be provided for the financial year 2023-24. If the same is not available, information for the financial year 2022-23 may be provided.



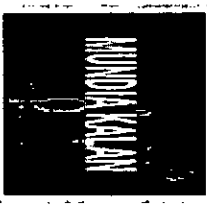
